MANUFACTURER'S LIMITED WARRANTIES

*MANUFACTURER'S LIMITED WARRANTIES FOR ALL PRODUCTS
MANUFACTURED BY SAUTTIS, LLC AND SOLD UNDER SAUTTIS LABEL ARE
SUBJECT TO SPECIFIC AND IMPLIED WARRANTIES AS FOLLOWS:*

SIX YEAR STRUCTURAL WARRANTY

Subject to the requirements, exclusions, and limitations stated below, Sauttis, LLC warrants that the structural components of your trailer are free from defects in materials and workmanship under normal use and service for a period of six (6) years from the original warranty start date at the time you take possession of the trailer at initial purchase. This warranty applies exclusively to the trailer's structure, including the main frame, cross-members, railing, and sub-frame components.

TWO YEAR LIMITED WARRANTY

Subject to the requirements, exclusions and limitations stated below, Sauttis, LLC provides a two-year limited warranty covering all trailer components. trailer is warranted to the original retail purchaser against defects in materials and workmanship by Sauttis, LLC, arising from normal use for two (2) years from the original warranty start date at the time you take possession of the trailer at initial purchase.

EXCLUSIONS TO ALL WARRANTY COVERAGE

1. This warranty does not cover any trailer or portion of any trailer which has been repaired, altered, modified, or changed outside the knowledge and involvement of Sauttis, LLC.



2. This warranty does not cover damage or product failure caused by accident, misuse, negligence, tampering, overloading, vandalism, act of god, improper storage, alterations, failure to maintain, improper attachment, improper maintenance, improper use or any action or inaction outside the control of Sauttis, LLC.

3. Sauttis, LLC warrants its paint finish to be consistent with industry standards for 90 days from the date of original retail purchase, with the exceptions of “normal use” limitations set forth below and of deterioration due to use or exposure, such as chipping, scratching, fading, cracks in caulk seams, road salt or tar, damage by animals or pressure washing. Warrantable paint repairs are limited to spot repairs and blending consistent with standards in the trailer industry.

4. Lumber is warranted for 90 days from the date or original retail purchase.

NORMAL USE, NO REPAIRS OR ALTERATIONS

This Limited Warranty covers only defects in original components which arise from normal use and does not apply if the trailer has been subjected to negligence, accident, abuse, misuse, neglect, overload or has been repaired or altered without the prior written consent of Sauttis, LLC. Normal wear items, including but not limited to struts, lights, bearings, brakes, brake linings, tires and batteries will not be replaced due to wear.

TRANSPORTATION COSTS EXCLUDED

Transportation of any trailer to and/or from your dealer or any Sauttis approved repair facility shall be the responsibility of the trailer owner. Sauttis, LLC shall not be liable for any such costs.

No reimbursement will be made to any dealer or owner for repairs made without the prior written consent of Sauttis, LLC. Any defective part(s) must be sent by prepaid



freight to Sauttis, LLC in order to qualify for replacement or reimbursement under this Limited Warranty.

OTHER PRODUCTS EXCLUDED

This Limited Warranty applies exclusively to trailers manufactured by Sauttis, LLC. Authorized repairs do not extend the term of this Limited Warranty.

LIMITATIONS

THE SOLE RESPONSIBILITY OF SAUTTIS, LLC UNDER THIS LIMITED WARRANTY SHALL BE TO REPAIR AND REPLACE PARTS AT A SAUTTIS TRAILERS FACTORY; HOWEVER, UNDER UNUSUAL CIRCUMSTANCES WITH PRIOR WRITTEN APPROVAL AND AT SAUTTIS, LLC'S DISCRETION, A REASONABLE ALLOWANCE MAY BE MADE FOR REPAIR OFF SITE. ALL OTHER OBLIGATIONS OR LIABILITIES, INCLUDING INCIDENTAL OR CONSEQUENTIAL DAMAGES OR CONTINGENT LIABILITIES ARISING OUT OF THE FAILURE OF ANY PARTS TO OPERATE PROPERLY ARE HEREBY EXCLUDED, INCLUDING BUT NOT LIMITED TO ANY DAMAGES RESULTING FROM LOSS OF USE, INCONVENIENCE, LOSS OF TIME, COMMERCIAL LOSS OR ANY OTHER TYPE OF DAMAGES, GENERAL OR SPECIFIC, FORESEEN OR UNFORESEEN, UNLESS APPLICABLE STATE LAW PROVIDES OTHERWISE.

THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACT HERE. NO ONE, INCLUDING AN AUTHORIZED SAUTISS TRAILERS DEALER, IS AUTHORIZED TO MAKE FURTHER OR ADDITIONAL WARRANTIES ON BEHALF OF SAUTISS, LLC. ALL IMPLIED WARRANTY OF MERCHANTABILITY AND FITNESS FOR INTENDED USE ARE LIMITED TO WARRANTY PERIODS STATED ABOVE, UNLESS ANY APPLICABLE STATE LAW PROVIDES OTHERWISE.



DISPUTES UNDER THIS LIMITED WARRANTY

This Limited Warranty shall be deemed to have been made in the State of Ohio (without regard to the conflict of law principals of the State), including all matters of construction, validity and performance regardless of the location of the trailer. You expressly waive any and all right to jury trial regarding any dispute hereunder. You hereby irrevocably submit to the exclusive jurisdiction and venue of courts sitting in Lucas County, Ohio. You hereby irrevocably waive, and hereby agree not to assert by way of motion, defense, or otherwise, any claim that you are not subject personally to the jurisdiction of such courts, that the Product or any other property of yours is exempt or immune from attachment or execution, that any action brought under this Limited Warranty is brought in an inconvenient forum, that the venue of the action is improper or that this Limited Warranty cannot be enforced by any such courts.

REQUIREMENT WARRANTY CLAIM PROCEDURE

Within five (5) days after discovering a problem with your Sauttis trailer, you must return your trailer for inspection to the location where you purchased your trailer.

If the seller cannot repair the problem free of charge and you want to file a claim under this Warranty and within ten (10) days of your discover of the defect, send a Limited Warranty Claim form to Sauttis, LLC by mail at the address listed above with all required information.

Sauttis, LLC will acknowledge such receipt of claim verbally or in writing to you. Sauttis, LLC will respond as soon as possible, but no later than thirty (30) days after receipt of the claim. Any defective part(s) must be sent by prepaid freight to Sauttis, LLC in order to qualify the claimant for replacement under this Limited Warranty. **ALL DEFECTIVE PARTS MUST BE RETURNED TO SAUTTIS, LLC WITHIN 30 DAYS FROM DATE OF SAUTTIS APPROVAL TO QUALIFY FOR REPLACEMENT.**

Sauttis, LLC will not reimburse any claimant for any adjustment or repair of a Sauttis trailer without prior written approval by Sauttis, LLC.

Sauttis, LLC reserves the right to not pay unreasonable costs for replacement or repair defects in Sauttis trailers and may, at Sauttis, LLC's discretion, establish a



reasonable reimbursement for any authorized work performed under the terms of this Limited Warranty.

SAUTTIS, LLC MAKES NO OTHER EXPRESS OR IMPLIED WARRANTIES AND THERE ARE NO OTHER WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THIS LIMITED WARRANTY.
